

Molton Brown x Lefty's Right Mind March 2025 Social Media Sweepstakes

Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT IMPROVE YOUR CHANCES OF WINNING.

Sweepstakes may only be entered in or from the 50 United States and the Districts of Columbia and entries originating from any other jurisdiction are not eligible for entry. This sweepstakes is governed exclusively by the laws of the United States. You are not authorized to participate in the sweepstakes if you are not located within the 50 United States or the District of Columbia.

- 1. Eligibility.** Participation open only to legal residents of the fifty United States or the District of Columbia, who are 18 or older as of date of entry. Void outside of the 50 United States and the District of Columbia, and where prohibited, taxed or restricted by law. Employees, officers and directors of Sponsor, dBb Group LTD. dba Lefty's Right Mind ("Prize Provider"), and their respective parent companies, subsidiaries, affiliates, partners, advertising and promotion agencies, manufacturers or distributors of Sweepstakes materials and their immediate families (parents, children, siblings, spouse) or members of the same household (whether related or not) of such employees, officers, and directors are not eligible to enter. How to Enter.** During the Sweepstakes Period, eligible entrants must follow @moltonbrownusa and @leftysrightmind on Instagram, like the Instagram post announcing the Sweepstakes ("Sweepstakes Post"), tag two (2) friends' accounts (with whom you have a personal relationship) in the comments of the Sweepstakes Post. You will automatically receive one (1) entry into the Sweepstakes drawing ("Entry")

BONUS ENTRY: entrants can share the Sweepstakes Post via Instagram stories for one (1) bonus Entry, including #moltonbrownsweepstakes. An entrant's account must be set to public to be eligible for bonus Entry.

Limit two (2) Entries in Sweepstakes per person. No automated entry devices and/or programs permitted. All entries become the sole exclusive property of the Sponsor and receipt of entries will not be acknowledged or returned. Delivery of prizes required a street address (no P.O. Boxes). Sponsor is not responsible for lost, late, illegible, stolen, incomplete, invalid, unintelligible, misdirected, postage-due, technically corrupter or garbled entries or mail, which will be disqualified, or for problems of any kind whether mechanical, human or electronic. Proof of submission will not be deemed to be proof of receipt by Sponsor. - 4. Random Drawing/Odds.** Two (2) winners will be selected in a random drawing from all eligible entries received during the Sweepstakes Period held on or about April 10, 2025. Odds of winning depend on the number of eligible entries received for the drawing. By entering the Sweepstakes, entrants fully and unconditionally agree to be bound by these rules and the decisions of the Sponsor, which will be final and binding in all matters relating to the Sweepstakes.

5. **Prize.** Two (2) prizes will be awarded, each consisting of two (2) sets of Hand Painted Tea Cup and Tea Saucer Set (\$6 each), and Molton Brown Bluebell & Wild Strawberry Collection: 300ml Bath & Shower Gel (\$35); 300ml Body Lotion (\$44); 7.5ml Travel Fragrance; and 100ml Eau de Parfum (\$180) (collectively, the “Prize”). Total Retail Value of the Prize is \$301.

Prize is non-transferable. No substitutions or cash redemptions. In the case of unavailability of any prize component, Sponsor reserves the right to substitute a prize of equal or greater value. Winners will be notified via direct message on Instagram by @moltonbrownusa within 48 hours after the drawing. Sponsor will also announce the winners by sharing the winner’s Instagram handle via an Instagram story after the winner is notified via direct message. Except where prohibited, the winners must respond to the direct message from Sponsor within seven (7) days of the date notice or attempted notice is sent in order to claim the prize. Winners will be required to provide a valid mailing address to Sponsor, and Sponsor retains the right to confirm any winners’ eligibility to participate. If winners cannot be contacted and do not provide a valid mailing address within 7 days of the Sponsor’s notice/attempted notice or if prize is returned as undeliverable, the winners forfeit his/her prize. Upon Prize forfeiture, no compensation will be given. 8. **Additional Terms.** In case of dispute as to the identity of any entrant, Entry will be declared made by the authorized account holder of the Instagram account submitted at the time of entry. “Authorized Account Holder” is defined as the natural person who is assigned an Instagram account by an Internet access provider, online service provider, or other organization (e.g. business, educational, institutional, etc.) responsible for assigning Instagram account or the domain associated with the submitted Instagram account. Any Potential Winner may be requested to provide Sponsor with proof that such winner is the authorized account holder of the Instagram account associated with the winning entry. Any other

attempted form of entry is prohibited; no automatic, programmed, robotic or similar means of entry are permitted.
