

2024 Molton Brown USA November Account Update Sweepstakes

Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT IMPROVE YOUR CHANCES OF WINNING.

Sweepstakes may only be entered in or from the 50 United States and the Districts of Columbia and entries originating from any other jurisdiction are not eligible for entry. This sweepstakes is governed exclusively by the laws of the United States. You are not authorized to participate in the sweepstakes if you are not located within the 50 United States or the District of Columbia.

1. **Eligibility.** Participation open only to those who opted in to receive emails from Sponsor AND received a Sweepstakes email ("Sweepstakes Email") who are legal residents of the fifty United States or the District of Columbia, who are 18 or older as of date of entry. Void outside of the 50 United States and the District of Columbia, and where prohibited, taxed or restricted by law. Employees, officers and directors of Sponsor and its parent companies, subsidiaries, affiliates, partners, advertising and promotion agencies, manufacturers or distributors of Sweepstakes materials and their immediate families (parents, children, siblings, spouse) or members of the same household (whether related or not) of such employees, officers, and directors are not eligible to enter. (You must click the link in the Sweepstakes Email; if you access your account without using the link provided in the Sweepstakes Email, your entry will not be logged).
 - b) Log into your online account.
 - c) Visit your "Preference Center", available from your Account Dashboard, and enter or update "Your interests" and "How would you like to hear from us" drop-down sections.
 - d) Click "Save Preferences" under each drop-down section to ensure that your details have been saved, within the Sweepstakes Period.

You will automatically receive one (1) entry into the Sweepstakes drawing ("Entry"). Limit one (1) Entry per person.

All entries become the sole exclusive property of the Sponsor and receipt of entries will not be acknowledged or returned. Delivery of prizes required a street address (no P.O. Boxes). Sponsor is not responsible for lost, late, illegible, stolen, incomplete, invalid, unintelligible, misdirected, postage-due, technically corrupter or garbled entries or mail, which will be disqualified, or for problems of any kind whether mechanical, human or electronic. Proof of submission will not be deemed to be proof of receipt by Sponsor.
