Seabourn and Molton Brown Prize Draw (the “Competition”)

Terms and Conditions

The promoter is Carnival plc trading as Seabourn whose registered office is at Carnival House, 100 Harbour Parade, Southampton, SO15 1ST (“**Promoter**” “**we**” or “**us**”).
