

## **-Terms and Conditions for Molton Brown's 50<sup>th</sup> Anniversary Giveaway**

1. The 'Promoter' of the competition is Molton Brown Limited, whose registered office is 130 Shaftesbury Avenue, London W1D 5EU (registered in England and Wales under company number 02414997).
2. The competition is only open to residents of the United Kingdom who are aged 18 and over, excluding employees or immediate families of the Promoter, or its affiliate companies, agents or any third party professionally connected with the competition.
3. To enter the competition, participants must write a comment sharing their first or favourite Molton Brown memory in the comments section below the post on Instagram promoting this giveaway ("Entry Content").
4. No purchase is necessary, however internet access and a valid Instagram account is required.
5. Entries are accepted from the time the first Instagram post promoting the competition goes live from @MoltonBrown and entries will close at 3pm (BST) on Monday, 9<sup>th</sup> August 2021 (the "Competition Period").
6. Each person can enter multiple times but must write a new comment each time with a different memory for each entry to be valid.

One (1) winner will be selected at random by the Promoter at the end of the Competition Period from all valid entries received during the Competition Period and will be contacted by the Promoter soon after the competition closes via a direct message to their Instagram account used to submit the Entry Content, advising them of their prize and the steps required to claim this. Participants should ensure their Instagram settings permit direct messages of this nature to be received. Promoter does not accept any responsibility for messages not received by the winner.
8. In the event the Promoter cannot for any reason contact the winner within five (5) days of first attempting to do so, the Promoter reserves the right to select an alternate winner from all valid entries received during the Competition Period.
