

Molton Brown 2024 Christmas Match 3 Game
Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT IMPROVE YOUR CHANCES OF WINNING.

Competition may only be entered in or from the 50 United States and the Districts of Columbia and entries originating from any other jurisdiction are not eligible for entry. This competition is governed exclusively by the laws of the United States. You are not authorized to participate in the competition if you are not located within the 50 United States or the District of Columbia.

- 1. Eligibility.** Participation is open only to legal residents of the fifty United States or the District of Columbia, who are 18 or older as of date of entry. Void outside of the 50 United States and the District of Columbia, and where prohibited, taxed or restricted by law. By entering the competition, participants agree that they have read and understood these terms and conditions as well as Molton Brown’s [General Competition Terms and Conditions](#) which apply to all competitions run by or on behalf of the Sponsor.

Participants must match three (3) of the same tiles to get points and must achieve a pre-defined score in order to pass each level. If a participant passes level two (2), four (4), six (6), eight (8), and/or ten (10), they will receive the following offers (“Offers”):

In order to take advantage of the Offers, each participant will receive a unique code within the game which the participant can copy and paste online. The code may only be used once and must only be used by the participant. All codes received during the game will be valid until 11:59pm on 31st December 2024. Participants must ensure that they keep a record of their unique code in order to redeem the offer as an email copy will not be provided. Participants will not be able to claim their offer without their unique code.

Participants will have the opportunity to add their name to the leaderboard for a chance to win a prize ("Prize") in the Grand Prize Draw ("Grand Prize Draw"). To join the leaderboard, participants must pass Level 1 and must provide their first name, last name, and email address. These details will be processed in accordance with Peek and Poke's [Privacy Policy](#).

There is no limit on how many times an entrant may play the game, but each entrant will have only one (1) chance to be selected for the Grand Prize Draw

The game is administered by Peek and Poke on behalf of the Sponsor.

- 3. Random Drawing/Odds.** One (1) winner will be selected at random from all participants on the leaderboard at the end of the Competition Period to win the Grand Prize Draw.
